The Portfolio is a Feeder Portfolio and pursues its objective by investing substantially all of its assets in its corresponding Master Fund, The Tax-Managed U.S. Marketwide Value Series, which has the same investment objective and policies as the Tax-Managed U.S. Marketwide Value Portfolio.

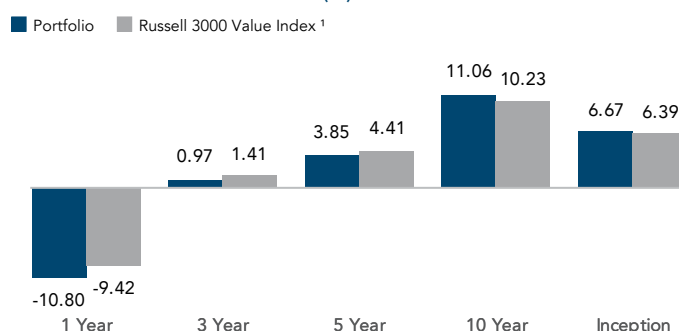
PRINCIPAL RISKS
