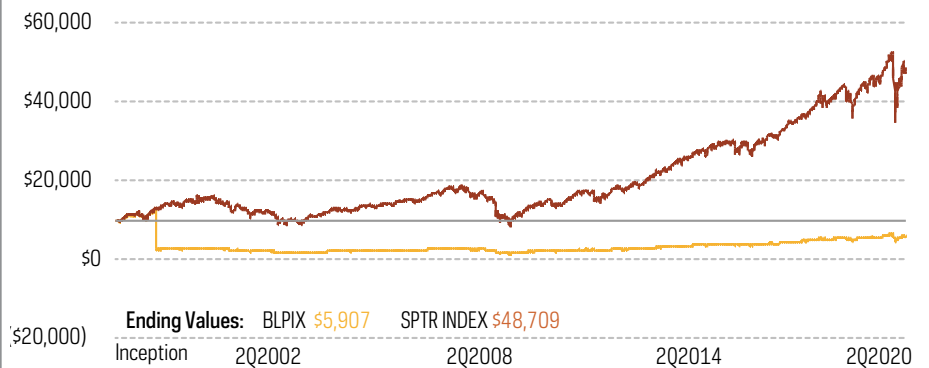

■ Bull (BLPIX) ■ S&P 500 Index


