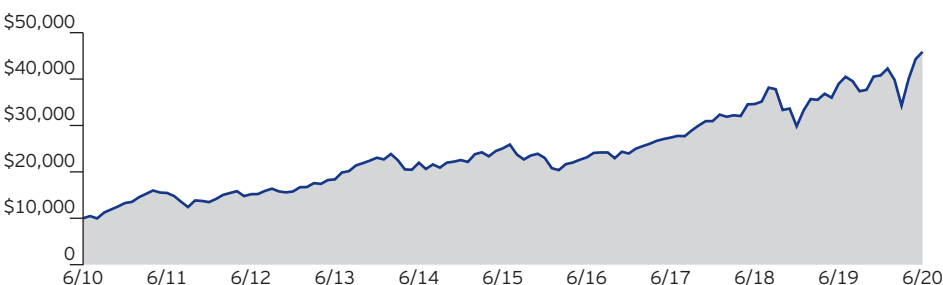

The overall rating is derived from a weighted average of three-, five- and 10-year rating metrics, as applicable, excluding sales charges and including fees and expenses. Had fees not been waived and/or expenses reimbursed currently or in the past, the Morningstar rating would have been lower. Class A shares received 5 stars for the overall, 4 stars for the three years, 5 stars for the five years and 5 stars for the 10 years. The fund was rated among 577, 577, 508 and 377 funds within the Morningstar Small Growth Category for the overall period, three, five and 10 years, respectively.
