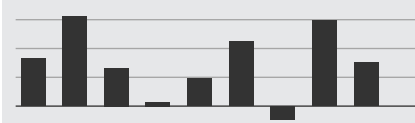

The Fund was rated 3 and 4 stars against 1225 and 1068 funds in the category for the three- and five- year periods, respectively.
