

## Rydex S&P Pure Style Mutual Funds

### FUND HIGHLIGHTS & APPLICATIONS

- May outperform traditional style box funds in certain market cycles due to their narrower selection of growth and value stocks as well as their style score weightings
- Have potentially lower correlation between pure growth and value indices relative to their traditional style indices
- Growth factors include sales growth, earnings change to price, and momentum
- Value factors include book value-to-price ratio, sales-to-price ratio, and earnings-to-price ratio

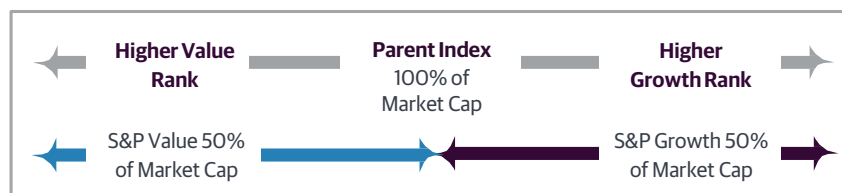

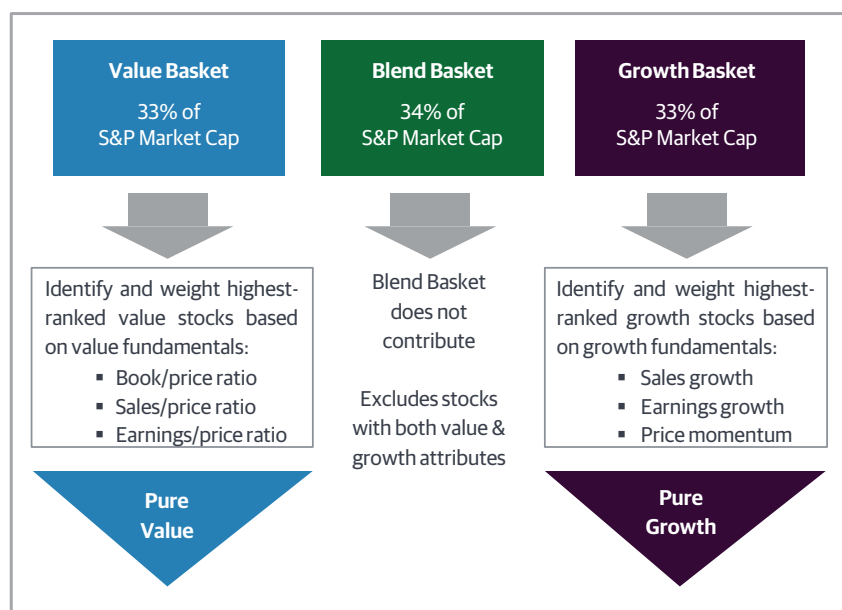
S&P Pure Style Indices

Rydex S&P Pure Style mutual funds are benchmarked to the S&P Pure Style Indices. The indices use a quantitative rules-based selection process to include only those stocks exhibiting strong growth or value characteristics. Stocks are selected if they show growth or value characteristics that meet minimum style score criteria while stocks with overlapping growth and value characteristics are eliminated. Stocks are weighted according to their style scores, as opposed to being weighted by market capitalization.
