FUND DESCRIPTION

The investment objective of Horizon's Active Dividend Fund is capital appreciation and current income.

The fund's investment adviser, Horizon Investments, seeks to achieve the investment objective by investing primarily in the equity securities of U.S. and foreign dividend paying companies.

ASPECTS OF THIS ACTIVE FUND

The Active Dividend Fund employs a fundamental bottom-up process to identify companies that Horizon believes have one or more of the following characteristics:

- Dividend-paying;
- Favorable long-term fundamental characteristics;
- Priced below what Horizon believes to be the Company's intrinsic value;
- Projected ability to grow intrinsic value per share over the long-term.
