The Tweedy, Browne Value Fund seeks long-term growth of capital by investing primarily in U.S. and foreign equity securities that the Adviser believes are undervalued. Investments are focused in developed markets. The Fund seeks to reduce currency risk by hedging its perceived foreign currency exposure back into the U.S. dollar where practicable.

COMMITMENT OF THE ADVISER

As of March 31, 2021, the current Managing Directors and retired principals and their families, as well as employees of Tweedy, Browne, had more than \$1.4 billion in portfolios combined with or similar to client portfolios, including approximately \$88.1 million in the Value Fund. Investment Committee members have spent between 12 to 47 years working at Tweedy, Browne. No principal has ever left the firm except for the reason of retirement.


