Per the most recent prospectus, (1) Fund total Operating expense ratios are (1)Class A 1.76%; Class L 2.51%; Institutional 1.51% and (2) Fund net annual operating expense ratios are: Class A 1.28%; Class L 2.03% Institutional 1.03%. In the interest of limiting expenses of the Fund, the Adviser has entered into a contractual expense limitation agreement with the Trust, effective March 31, 2021, so that the Fund's ratio

of total annual operating expenses is limited to 1.24% for Class A Shares, 1.99% for Class L Shares, and 0.99% for Institutional Class Shares excluding acquired fund fees and expenses until at least May 31, 2022.
