

The Guggenheim Directional Allocation Index<sup>SM</sup> consists of various combinations of the Directional Series Indices (Guggenheim RBP\* Large-Cap Aggressive, Market and Defensive Indices) to position the portfolio for changing market cycles, allocating up to 100% in cash if warranted.





