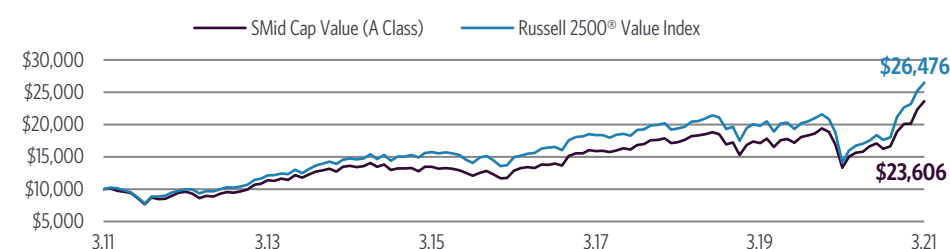

The Institutional Class was rated, based on its risk-adjusted returns, 4 stars for the Overall, 3-year, 5-year, and 3 stars for the 10-year periods among 415, 395, 350, and 250 Mid-Cap Value funds, respectively. The Morningstar Rating for funds, or "star rating", is calculated for managed products with at least a three-year history and does not include the effect of sales charges. Exchange-traded funds and open-end mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics.

Fund Highlights and Applications

- Invests in a diversified portfolio of small- and medium-sized U.S. companies.
- Selects securities of small- and medium-sized companies that appear undervalued by the overall market relative to assets, earnings, growth potential or cash flows.
- Applies a valuation-focused stock selection process that combines fundamental research with a proprietary quantitative screening process to identify companies we believe have the potential to outperform.

The Fund has adopted the Predecessor Fund's performance history with respect to its Institutional Class shares. Accordingly, the performance of the Institutional Class shares of the Fund shown is the performance of the Predecessor Fund. The returns have not been restated to reflect the fees and expenses applicable to the Institutional Class shares of the Fund and could have been lower had such an adjustment been made. ³ Returns are for the period 5.01.1997-3.31.2021 (since inception of SMid Cap Value Fund A Class).

The P/E ratio of a stock is calculated by dividing the current price of the stock by its trailing 12-month's earnings per share. **The price/book ratio** is the market price of a stock divided by the book value per share. **Return on equity** is net income divided by net worth. **The three-year EPS growth rate** is a weighted average of each stock holding's growth rate in earnings per share (EPS). EPS is total earnings divided by the number of shares outstanding. This measure is not a forecast of the fund's performance.
