INVESTMENT STRATEGY



Under normal market conditions, the Fund invests in the equity securities of companies that pay current dividends and that the Fund's portfolio managers believe have the potential to increase their dividends with regularity. Equity securities in which the Fund invests consist primarily of

common stocks, but may also include MLPs and REITs. The Fund will invest primarily in securities of U.S. companies, but may invest up to 20% of its net assets in foreign companies through investments in ADRs. The Fund invests in companies in numerous market sectors and with various market capitalizations. The portfolio managers expect to invest mainly in large-capitalization companies (those with market capitalizations of \$10 billion and higher), but may also invest in midcapitalization companies (market capitalizations of \$2 billion to \$10 billion) and small-capitalization companies (market capitalization of less than \$2 billion). The Fund will generally remain fully invested, and under normal market conditions, the Fund's portfolio will consist of approximately 30 to 80 companies.



P/E to Growth is the Estimated P/E divided by the Estimated 3-5 Year EPS Growth. Beta is a measure of the degree of change in value one can expect in a portfolio given a change in value in a benchmark index. A portfolio with a beta greater than one is generally more volatile than its benchmark index. Return on Equity (ROE) is the percentage a company earns on its shareholders' equity in a given year. The calculation is net income divided by end-of-year net worth, multiplied by 100. LT Debt/Capital is calculated by dividing long-term debt by total capitalization (the sum of common equity plus preferred equity plus long-term debt).
