High-Quality Growth — Searches for quality, high-return growth businesses with strong profitability and durable franchises, trading at attractive valuations





The index is calculated on a total return basis with net dividends reinvested.  $Morning star\ Rating^{\text{TM}}\ for\ funds,\ or\ 'star\ rating,'\ is\ calculated\ for\ managed\ products\ (including\ mutual\ products)$ funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
