DWS RREEF Global Infrastructure Fund seeks to take advantage of the opportunities these changes present by investing in the securities of global companies that own and operate physical infrastructure assets as their core business. The team believes this type of investing best replicates the unique investment characteristics of the infrastructure asset class.

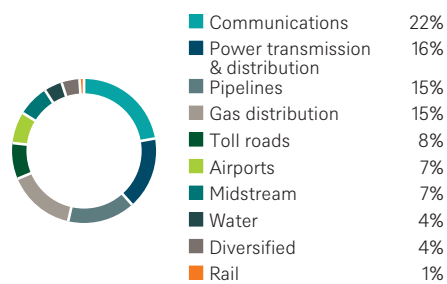

The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10 year (if applicable) Morningstar Rating metrics. The weights are 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
