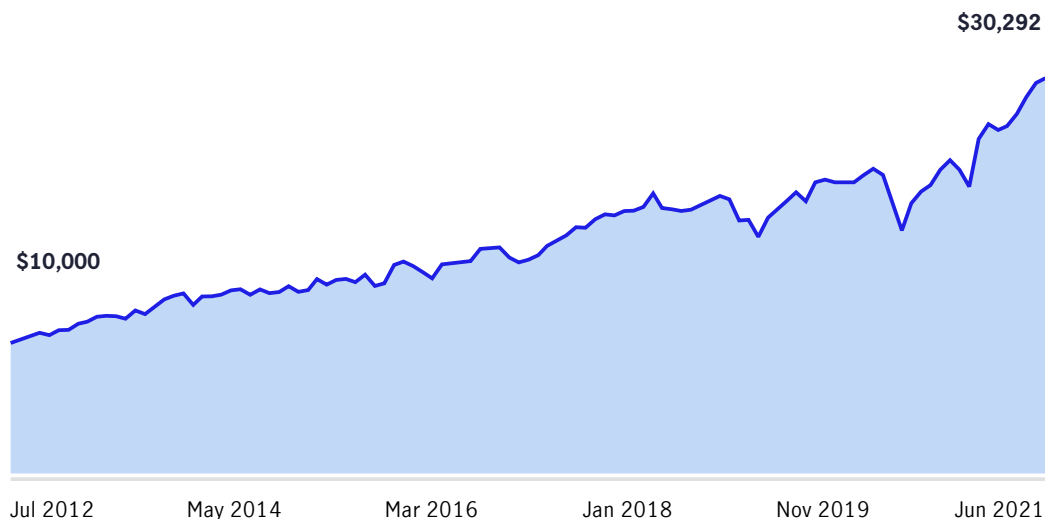

Class I without sales charge – 7/1/12 – 6/30/21

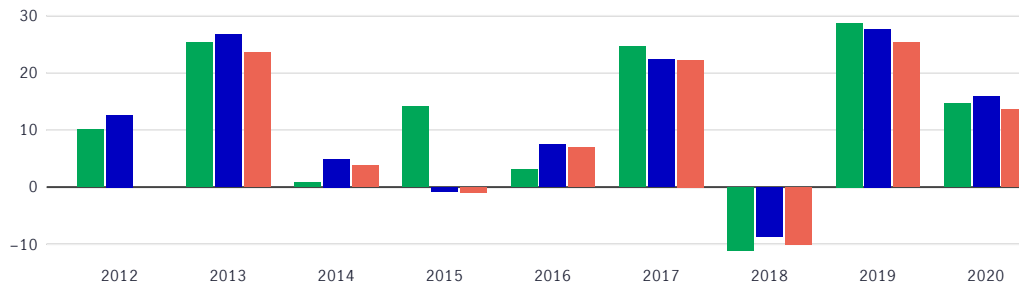

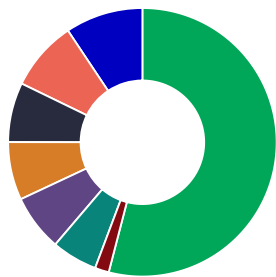
