Fund description

The Fund seeks a favorable long-term total return, mainly through capital appreciation. Under normal circumstances, The Fund invests at least 80% of its assets in small-cap equity securities of foreign issuers, primarily those believed to have favorable prospects for long term capital appreciation. A small cap equity security is a security within the capitalization range of companies included in its benchmark, the MSCI ACWI ex USA Small Cap Index. The Fund may invest in equity securities of small companies across a wide range of sectors, growth rates and valuations. The Fund maintains investments of equity securities of foreign issuers in at least three countries other than the United States. The Fund's investment manager uses proprietary quantitative models to evaluate and score a broad universe of stocks in which the Fund invests.

Portfolio management

Effective 17 Aug 2020, Max Kozlov was added as a portfolio manager on the strategy; Antonio Ramos and Steven Rossiello are no longer be portfolio managers on the strategy.

Glossary

Beta is a measure of the volatility of a portfolio relative to the overall market. A beta less than 1.0 indicates lower risk than the market; a beta greater than 1.0 indicates higher risk than the market. **P/E ratio** of a stock is calculated by dividing the current price of the stock by its forecasted 12 months' earnings per share. The average of the price/earnings ratio of a fund is a weighted harmonic average of all the current P/E ratios (excluding negatives) of the stocks in the Fund's portfolio. This should not be construed as a forecast of the Fund's performance. **Standard deviation** is a statistical measure of the historical volatility of a mutual fund or portfolio; the higher the number the greater the risk. **Turnover ratio** is calculated by dividing the lesser of purchases or sales by the average value of portfolio assets during a period. Turnover is based on the portfolio's fiscal year end and is not annualized if the reporting period covers less than 12 months. **Weighted average market capitalization** is the portfolio-weighted mean capitalizations of all equity securities.

MSCI ACWI ex USA Small Cap Index is a free float-adjusted market capitalization weighted index that is designed to measure the small-cap equity market performance of developed and emerging market nations, excluding the United States. **It is not possible to invest directly in an index.**
