- Overweighting a market segment without additional cash



The Dow Jones U.S. Industrials SM Index (Bloomberg symbol: DJUSIN) seeks to measure the performance of certain companies in the industrial sector of the U.S. equity market. Component companies include, among others, building materials, heavy construction, factory equipment, heavy machinery, industrial services, pollution control, containers and packaging, industrial diversified, air freight, marine transportation, railroads, trucking, land-transportation equipment, shipbuilding, transportation services, advanced industrial equipment, electric components and equipment and aerospace. It is not possible to invest directly in an index.



Narrowly focused investments typically exhibit higher volatility.
