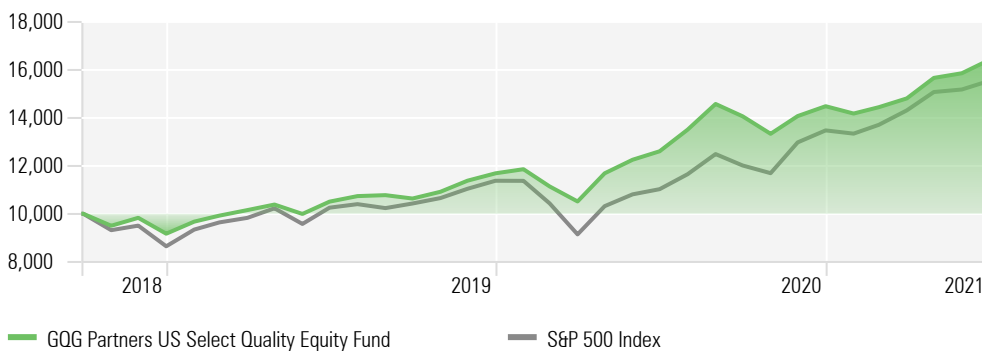

The GQG Partners US Select Quality Equity Fund seeks long-term capital appreciation.

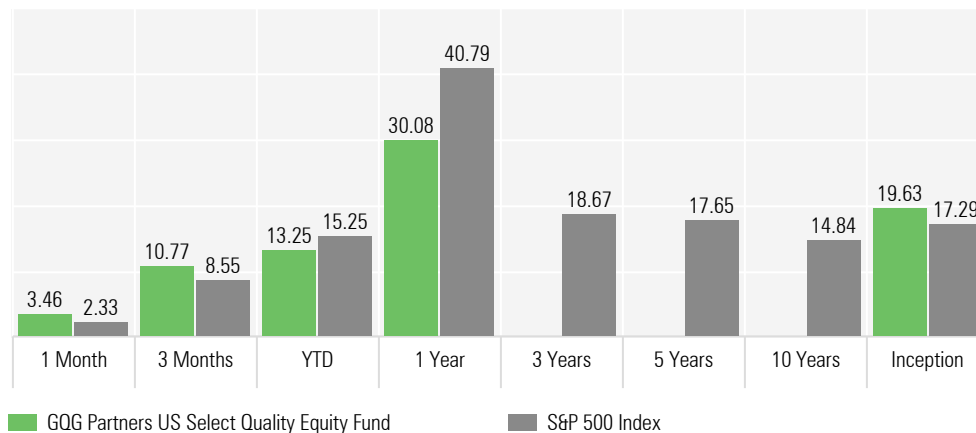

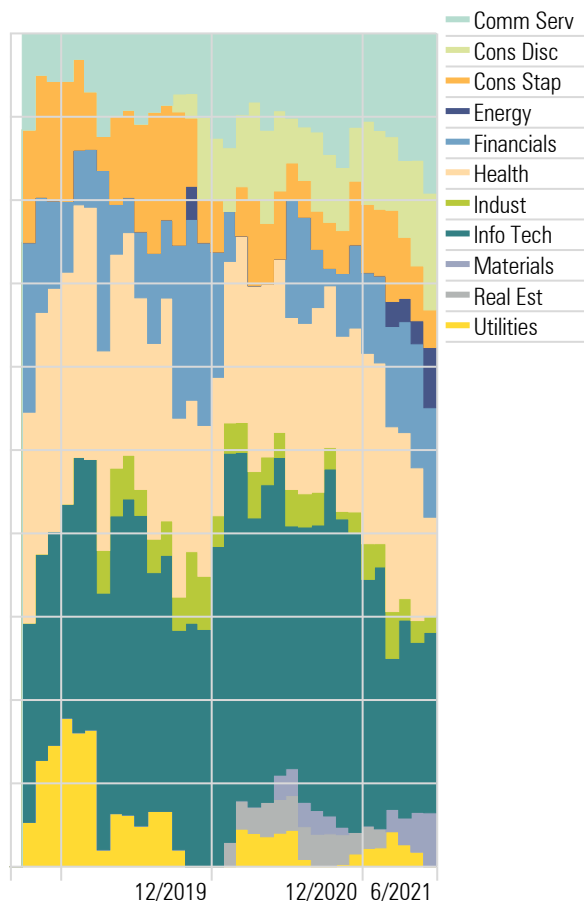

While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent 3-year period actually has the greatest impact because it is included in all three rating periods.
