



Tortoise MLP & Pipeline Fund (TORIX/TORTX) received a Four-Star Overall Morningstar Rating™ among 90 Energy Limited Partnership Funds (based on a weighted average of the fund's three-, five- and ten-year risk-adjusted return measure, if applicable) as of 6/30/2021.

The Tortoise MLP & Pipeline Fund focuses on the large and diverse North American pipeline universe, providing access to the sizable pipeline network of one of the world's largest consumers of energy. The fund has the ability and flexibility to access traditional pipeline corporations alongside MLPs. We believe these pipeline companies and MLPs have strong business fundamentals and expanded growth opportunities.

### Investment strategy

The fund intends to invest primarily in equity securities of MLPs and pipeline companies in the energy infrastructure sector. These companies transport, gather and process, distribute and/or store natural gas, natural gas liquids, crude oil and refined petroleum products (including biodiesel and ethanol).



Through its in-house research coverage of companies throughout the entire energy value chain, Tortoise's investment process uses a bottom-up, fundamentals-based approach. Tortoise believes its process is a competitive advantage, allowing it to evaluate risk and reward intelligently across the energy infrastructure universe.

The Morningstar Rating™ for funds, or "star rating," is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds and separate accounts) with at least a three-year history without adjustment for sales load. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive five stars, the next 22.5% receive four stars, the next 35% receive three stars, the next 22.5% receive two stars, and the bottom 10% receive one star. The Overall Morningstar Rating<sup>TM</sup> for a managed product is derived from a weighted average of the performance figures associated with its three-, five- and 10-year (if applicable) Morningstar Rating™ metrics. The weights are: 100% three-year rating for 36 - 59 months of total returns, 60% five-year rating/40% threeyear rating for 60 - 119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. As of 6/30/2021, TORIX/ TORTX was rated against the following number of Energy Limited Partnership Funds over the following periods: 90, 75 and 21 for the three-year, five-year and 10-year time periods, respectively. TORIX/TORTX received three stars for the three- and five-year periods and four stars for the 10 year-period. Star ratings may be different for other share classes.
