Investment approach

- Seeks to track the performance of the S&P U.S. Dividend Growers Index.
- Passively managed, full-replication approach.
- Fund remains fully invested.
- Large-cap equity, emphasizing stocks with a record of growing their dividends year over year.
- Low expenses minimize net tracking error.

Note: Effective September 20, 2021, Vanguard Dividend Appreciation ETF changed its benchmark to the S&P U.S. Dividend Growers Index from the Nasdaq US Dividend Achievers Select Index. The information for the period prior to September 20, 2021 is based on the benchmark previously being the Nasdaq US Dividend Achievers Select Index.

About the benchmark

- The NASDAQ US Dividend Achievers Select Index is derived from the NASDAQ US Broad Dividend Achievers Index.
- Includes U.S. common stocks that have a history of increasing dividends for at least ten consecutive years.
- Excludes stocks that might have low potential for increasing dividends.
- Excludes REITs, which generally do not benefit from currently favorable tax rates on qualified dividends.




