OBJECTIVE: High level of current income

STRATEGY: Normally invests at least 80% of its assets in investment-grade debt securities of all types and repurchase agreements for those securities. The fund uses the Bloomberg U.S. Universal Bond Index as a guide in allocating its assets across the investment-grade, high-yield, and emerging-market asset classes and in managing the fund's overall interest rate risk. Invests up to 20% of its assets in lower-quality debt securities. Invests in domestic and foreign issuers and allocates assets across different asset classes, market sectors, and maturities. Analyzes the credit quality of the issuer, the issuer's potential for success, the credit, currency, and economic risks of the security and its issuer, security-specific features, current and potential future valuation, and trading opportunities to select investments. May engage in transactions that have a leveraging effect on the fund.



In general the bond market, especially foreign markets, is volatile, and can decline significantly in response to adverse issuer, political, regulatory, market, or economic developments. Fixed income securities carry interest rate risk. (As interest rates rise, bond prices usually fall, and vice versa. This effect is usually more pronounced for longer-term securities.) Fixed income securities also carry inflation risk, liquidity risk, call risk, and credit and default risks for both issuers and counterparties. Unlike individual bonds, most bond funds do not have a maturity date, so avoiding losses caused by price volatility by holding them until maturity is not possible. Bloomberg U.S. Aggregate Bond Index is a broad-based flagship benchmark that measures the investment-grade, U.S. dollar-denominated, fixed-rate taxable bond market. The index includes Treasuries, government-related and corporate securities, mortgage-backed securities (agency fixed-rate pass-throughs), asset-backed securities, and collateralized mortgage-backed securities (agency and non-agency). Bloomberg (BBg) U.S. Universal Bond Index represents the union of the BBg U.S. Aggregate Bond Index, the BBg Eurodollar Bond Index, the BBg Eurodollar Bond Index, the BBg Eurodollar Bund Index, and the non-ERISA portion of the BBg U.S. CMBS Index. Municipal debt, private placements, and non-dollar-denominated issues are excluded from the index. The only constituent of the index that includes floating rate debt is the Barclays Emerging Markets Aggregate USD Bond Index. Duration is a measure of a security's price sensitivity to changes in interest rates. Duration differs from maturity in that it considers a security's interest payments in addition to the amount of time until the security reaches maturity, and also takes into account certain maturity-shortening features (e.g., demand features, interest rate resets, and call options) when applicable. Securities with longer effective durations generally tend to be more sensitive to interest rate changes than a securities with shorter effective duration. Expense Ratio is the fund's total annual fund operating expenses as available in each fund's prospectus and represents the expenses that you pay each year as a percentage of the value of your investment. Any applicable brokerage charges are not included in the expense ratio. Morningstar Averages represent the average return of all funds within their respective fund investment category.
