OBJECTIVE: Provide investment returns that correspond, before fees and expenses, generally to the performance of the Fidelity U.S. Momentum Factor Index

STRATEGY: Invests at least 80% of assets in securities included in the Fidelity U.S. Momentum Factor Index. It may lend securities to earn income for the fund.

INDEX DESCRIPTION: The Fidelity U.S. Momentum Factor Index is designed to reflect the performance of stocks of large- and mid-capitalization U.S. companies that exhibit positive momentum signals.

DEFINITIONS AND IMPORTANT INFORMATION

Expense Ratio is the fund's total annual fund operating expenses as available in each fund's prospectus and represents the expenses that you pay each year as a percentage of the value of your investment.
