Fund description: The Fund seeks investment results that track, before fees and expenses, the price and yield performance of the NASDAQ Chaikin Power U.S. Large Cap Index. The NASDAQ Chaikin Power U.S. Large Cap Index is a rules-based, quantitative index, designed to enhance an existing index (NASDAQ US 1500 Index) by selecting stocks with the highest Chaikin Power Gauge rating. The Index rebalances and reconstitutes annually and typically consists of 45 to 65 equally weighted securities.

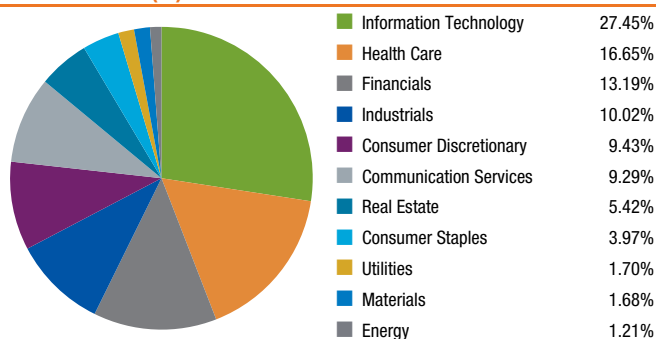
