Overview

The <u>Direxion Daily Small Cap Bull and Bear 3X Shares</u> seek the daily investment results, before fees and expenses, of 300%, or 300% of the inverse (or opposite), of the performance of the Russell 2000® Index. There is no guarantee the funds will meet their stated investment objectives.

These leveraged ETFs seek a return that is 300% or -300% of the return of their benchmark index *for a single day*. The funds should not be expected to provide three times or negative three times the return of the benchmark's cumulative return for periods greater than a day.

Target Index

The Russell 2000® Index (RU20INTR) measures the performance of approximately 2,000 small-capitalization companies in the Russell 3000® Index, based on a combination of their market capitalization and current index membership. *One cannot directly invest in an index.*
