

Daily Healthcare Bull 3X Shares

Overview

The [Direxion Daily Healthcare Bull 3X Shares](#) seeks daily investment results, before fees and expenses, of 300% of the performance of the Health Care Select Sector Index. **There is no guarantee the fund will meet its stated investment objectives.**

This leveraged ETF seeks a return that is 300% of the return of its benchmark index **for a single day. The fund should not be expected to provide three times the return of the benchmark's cumulative return for periods greater than a day.**

Target Index

The Health Care Select Sector Index (IXVTR) is provided by Standard & Poor's and includes domestic companies from the healthcare sector, which includes the following industries: pharmaceuticals; health care equipment and supplies; health care providers and services; biotechnology; life sciences tools and services; and health care technology. **One cannot directly invest in an index.**
