Overview

The <u>Direxion Daily Industrials Bull 3X Shares</u> seeks daily investment results, before fees and expenses, of 300% of the performance of the Industrials Select Sector Index. There is no guarantee the fund will meet its stated investment objective.

This leveraged ETF seeks a return that is 300% the return of its benchmark index for a single day. The fund should not be expected to provide three times the return of the benchmark's cumulative return for periods greater than a day.

Target Index

The Industrials Select Sector Index (IXITR) is provided by S&P Dow Jones Indices and includes domestic companies from the industrials sector which includes the following industries: aerospace and defense; industrial conglomerates; marine; transportation infrastructure; machinery; road and rail; air freight and logistics; commercial services and supplies; professional services; electrical equipment; construction and engineering; trading companies and distributors; airlines; and building products. *One cannot directly invest in an index.*

If these expenses were included, the expense ratio would be higher.
