- + Normally holds 50 to 70 stocks

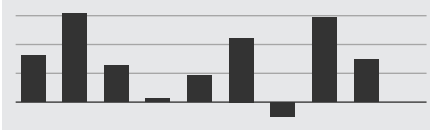
