INVESTMENT OBJECTIVE AND STRATEGY

The fund seeks to provide long-term capital growth by investing primarily in the common stocks of growth companies.

Invest primarily in common stocks of U.S. companies in sectors of the economy that, in T. Rowe Price's view, are the fastest growing or have the greatest growth potential.

Stock selection based on companies with the following:

- Earnings growth rates which generally exceed that of the average company in the Russell 3000 Index
- Favorable company fundamentals
- Effective management
- Reasonable stock valuations

BENEFITS AND RISKS

Potential for significant, long-term growth of capital by seeking to participate in the growth of companies positioned to benefit from the dynamic technological, social, medical, economic, and business developments that help define the current U.S. economic landscape.

Definitions

Morningstar rated the fund 4, 5, and 4 stars among 1,133, 1,024 and 762 Large Growth funds for the 3-, 5-, and 10-year periods (as applicable) ending 9/30/2021, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for funds with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star.
