

#### **3Q21 HIGHLIGHTS**

- The Fund returned -1.89% during the third quarter, bringing year to date performance to 22.89% through September 30th.
- Value strategies modestly underperformed broader markets during Q3 with MSCI World Value Index returning -0.67% compared to 0.09% for the MSCI World Index.
- During the quarter, the Fund initiated new positions in Valaris Ltd., following its emergence from bankruptcy in May, and in S&P 500 put options.
- During the quarter, the Fund exited its position in The Macerich Company.


