
WHY THE FUND?

R-Squared is a statistical measure that represents the percentage of a fund's movements that can be explained by movements in a benchmark index. Standard Deviation is a statistical measurement that helps to gauge the fund's historical volatility. Information Ratio is a ratio of portfolio returns above those of a benchmark compared to the volatility of those returns. Sharpe Ratio is a risk-adjusted measure calculated by using standard deviation and excess return to determine reward per unit of risk. Tracking Error is the difference between the price behavior of a fund and the price behavior of a benchmark. P/B Ratio is the ratio of the fund's market price to the most recently reported book value for the prior fiscal year. The 30-Day SEC Yield is computed in accordance with a standardized method prescribed by rules of the SEC. The 30-Day SEC Yield is computed by dividing the fund's investment income per share earned during a particular 30-day base period by the maximum offering price per share on the last day of the base period, and then annualizing the result. The 30-Day SEC Yield is calculated at each month end and updated within the first ten business days of the following month. Be advised that the 30-Day SEC Yield calculation does not account for return of capital.
