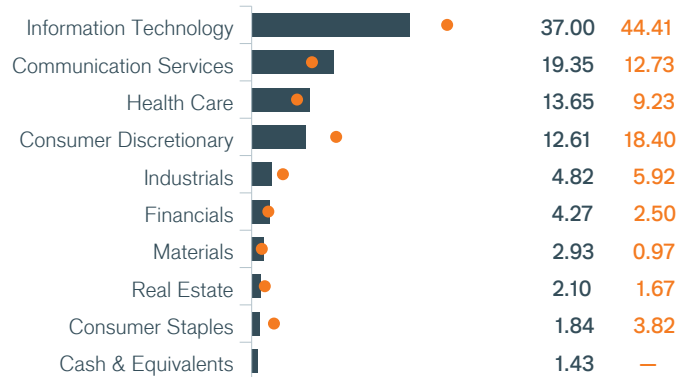

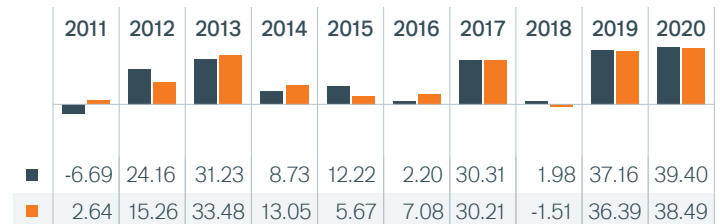
## Sector Allocation (%)
