Fund Highlights^{1,2}

- A low-volatility equity fund that combines an index-like portfolio of underlying equity securities with a portfolio of actively managed written index call options
- Consistent and attractive cash flow from index call writing creates potential for better long-term risk-adjusted returns than the equity market
- May be used as a component of an equity allocation or an alternatives program seeking equity market participation with reduced sensitivity to market swings; the fund is managed to maintain low correlation with fixed-income market returns and no significant sensitivity to changes in interest rates
- Fund uses the same investment strategy under all market conditions

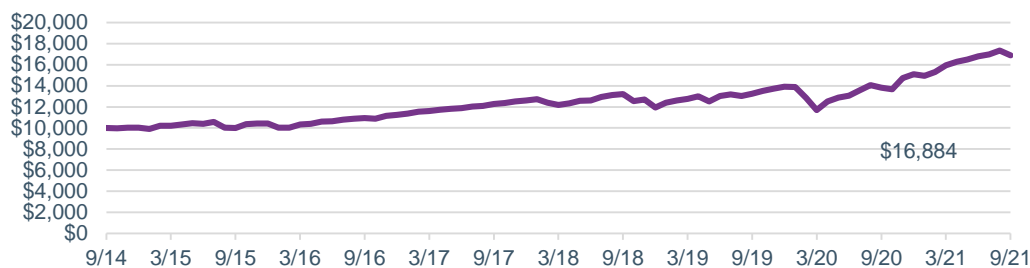

For each fund with at least a three-year history, Morningstar calculates a Morningstar Rating[™] used to rank the fund against other funds in the same category. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly excess performance, without any adjustments for loads (frontend, deferred, or redemption fees), placing more emphasis on downward variations and rewarding consistent performance. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. The top 10% of funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star (each share class is counted as a fraction of one fund within this scale and rated separately, which may cause slight variations in the distribution percentages). The SPX call is held until expiration and cash settled, at which time a new one-month, near-the-money call is written. 8 S&P 500® Index is a widely recognized measure of U.S. stock market performance. It is an unmanaged index of 500 common stocks chosen for market size, liquidity, and industry group representation, among other factors. 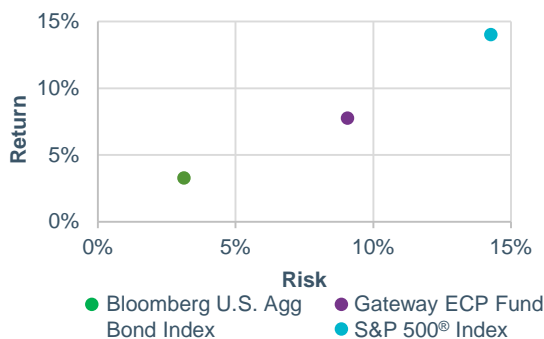
