Investment objective

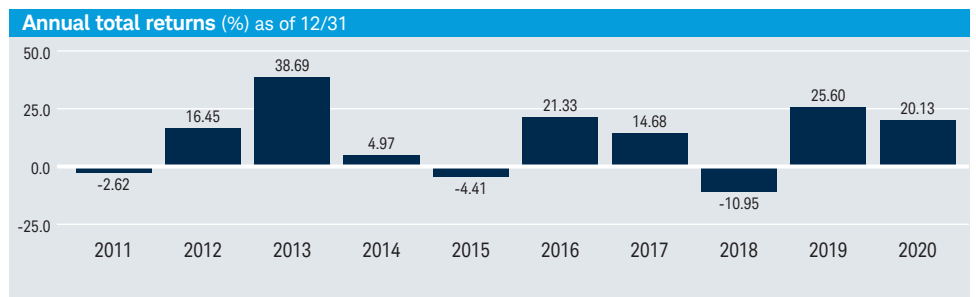
The Fund's goal is to track the performance of a benchmark index that measures the total return of small capitalization U.S. stocks.

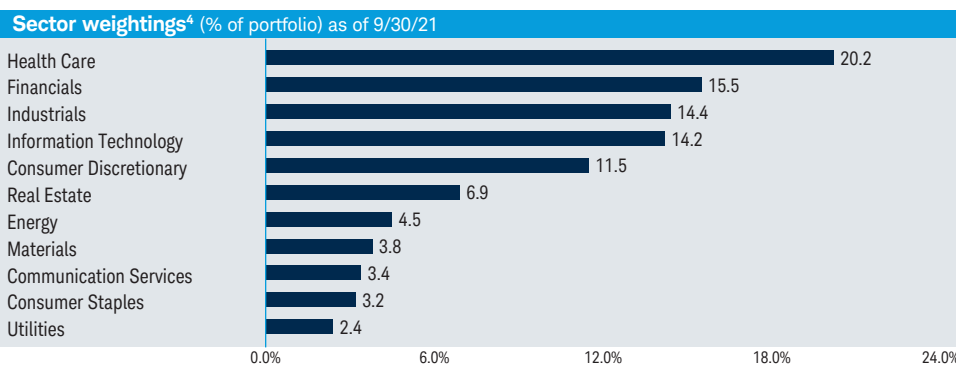
