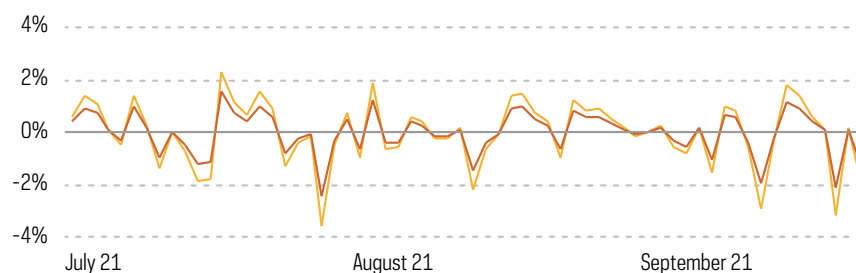

■ Consumer Services UltraSector (CYPIX) ■ Dow Jones U.S. Consumer Services Index


