FUND DESCRIPTION

The Fiera Capital Small/Mid-Cap Growth Fund (the "Fund") seeks to achieve long-term capital growth. The Fund seeks to achieve its investment objective by investing in a diversified portfolio of common stocks of small and mid-cap growth-oriented companies that are selected for their long-term capital appreciation potential and which are expected to grow faster than the U.S. economy. The investment team believes the intersection of bottom-up stock selection and the identification of global secular growth trends is the key driver of results. The team allocates to a combination of stable growth and emerging growth companies, tilting the allocation based on their economic outlook.
