

# Calvert US Large-Cap Value Responsible Index Fund

## Fund Overview

The Fund is designed to closely track the Calvert US Large-Cap Value Responsible Index, which is composed of the common stocks of the large growth companies as selected from the 1,000 largest publicly-traded U.S. companies based on market capitalization and value style factors. It offers broad exposure to companies that meet The Calvert Principles for Responsible Investment (Calvert Principles).

## Research Process

Calvert Research and Management conducts deep, proprietary research across approximately 200 peer groups using over 200 key performance indicators (KPIs) to measure material environmental, social, and governance (ESG) factors. The Calvert US Large-Cap Value Responsible Index has roughly 500 holdings that are reconstituted annually and are rebalanced quarterly.

The Calvert Principles provide a framework for the evaluation of ESG factors and guide our active engagement efforts with company managements.

- **McDonald's Corp:** Significant and ongoing labor controversies
- **Uber Technologies:** Significant controversies related to passenger and driver safety
