Fund Overview

The Fund is designed to closely track the Calvert US Large-Cap Growth Responsible Index, which is composed of the common stocks of the large growth companies as selected from the 1,000 largest publicly-traded U.S. companies based on market capitalization and growth style factors. It offers broad exposure to companies that meet The Calvert Principles for Responsible Investment (Calvert Principles).

Research Process

Calvert Research and Management conducts deep, proprietary research across approximately 200 peer groups using over 200 key performance indicators (KPIs) to measure material environmental, social, and governance (ESG) factors. The Calvert US Large-Cap Growth Responsible Index has roughly 550 holdings that are reconstituted annually and are rebalanced quarterly.
