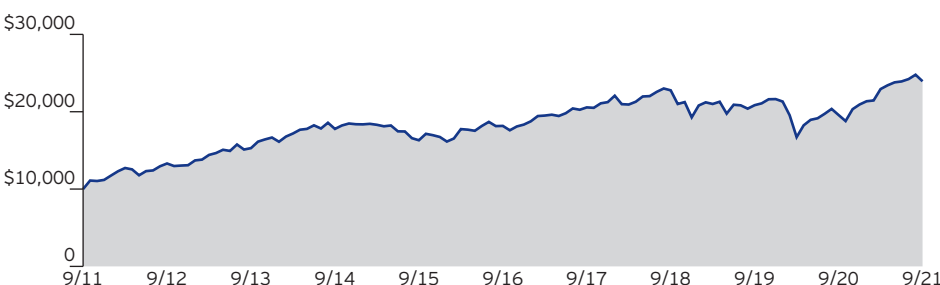
Had fees not been waived and/or expenses reimbursed, the SEC yields would have been 4.34% for Class A shares, 3.82% for Class C shares, 4.60% for Investor Class and 4.86% for Class Y shares.
