The LSV Global Managed Volatility Fund (the "Fund") applies the LSV quantitative model to a universe of stocks to create and maintain a broadly diversified portfolio of primarily large and mid-cap U.S., developed market non U.S., and emerging market non U.S. listed equities. The Fund aims for deep value orientation relative to the Fund benchmark, including low price to earnings, low price to cash flow, and high dividend yield relative to the Fund benchmark. The Fund also aims to manage volatility by selecting stocks whose total returns are expected to fluctuate less than those of the equity markets as a whole.



The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating periods. As of September 30, 2021, LSV Global Managed Volatility Fund (LSVFX, LVAFX) was rated against 153 U.S.-domiciled World Large Stock funds over a 3 year period and 141 funds over a five year period. With respect to these World Large Stock funds, LSVFX received a Morningstar rating of 2 stars for the three-year and five-year periods.
