# Market commentary

Equities finished the third quarter relatively flat, as a pullback in share prices in September offset earlier gains in July and August. The decline comes amid concerns over a moderation in economic growth rates, supply chain disruptions, and rising inflation. The top performing markets in our investable universe were Austria, Indonesia, Norway, Japan, and Portugal. The worst performing markets were China, South Korea, Peru, Hong Kong, and Belgium. The best performing sectors in the MSCI EAFE Index ("Index") were energy, information technology, and financials. The worst performing sectors were materials, utilities, and consumer discretionary. Currency proved a headwind as major currencies declined against the US dollar.

The Causeway International Value Fund ("Fund") underperformed the Index during the quarter, due primarily to stock selection. Fund holdings in the semiconductors & semi equipment, consumer services, pharmaceuticals & biotechnology, utilities, and software & services industry groups detracted from relative performance. Holdings in the capital goods, banks, insurance, and retailing industry groups, as well as an overweight position in the energy industry group, offset some of the underperformance compared to the Index. The largest detractor was integrated resort developer & operator, Sands China Ltd. (Hong Kong). Additional notable detractors included products & services provider for the electronic components industry, SK hynix, Inc. (South Korea), electronic equipment manufacturer, Samsung Electronics Co., Ltd. (South Korea), electric, gas & renewables power generation & distribution company, Enel SpA (Italy), and rolling stock, signaling, & services provider for the rail industry, Alstom SA (France). The top contributor to return was jet engine manufacturer, Rolls-Royce Holdings Plc (United Kingdom). Other notable contributors included banking & financial services company, UniCredit S.p.A. (Italy), electronic components manufacturer, Murata Manufacturing Co. Ltd. (Japan), property & casualty insurer, Sompo Holdings, Inc. (Japan), and crude oil & natural gas company, BP Plc (United Kingdom).
