

The Fund's investment adviser has contractually agreed to waive a portion or all of its management fees and pay Fund expenses (excluding acquired fund fees and expenses ("AFFE"), interest, taxes, interest and dividend expense on securities sold short and extraordinary expenses) to cap the fees at 1.55% for the institutional class and 1.80% for the investor class until at least February 28, 2023. The expense ratios as per the prospectus were 1.96% gross and 1.81% net for the institutional class and 2.22% gross and 2.07% net for the investor class. The net expense ratios are applicable to investors. The expense ratios are based on the estimated amounts and may not reflect the actual expense ratios.





Month End Attribution & Portfolio Commentary

For the month of November, the Otter Creek Long/Short Opportunity Fund fell approximately -0.35% while the S&P 500 depreciated -0.69%

During the month, investors aggressively sold equities during the last week of the month as concerns surrounding the emergence of a Covid mutation in South Africa and moderately hawkish comments from Federal Reserve Chairman Powell. Although the indexes fell modestly, individual securities experienced significantly higher volatility. Higher multiple growth stocks, a favorite for many institutional investors, small and mid-cap equities and commodities were hit especially hard.

At month end, the portfolio's delta-adjusted exposure was approximately 19.7%. As shown in the table above, our gross long equity exposure (delta adjusted) was 66.4%, while our gross short equity exposure was -47.6% (delta-adjusted). The fund has 10.8% of its capital invested in fixed income. Notably, we took the opportunity during the month to tax manage various long and shorts after earnings that resulted in a near-term reduction in our gross exposure.

During the month our long equity positions depreciated -0.8% while our short equity related positions, including put options, added 0.6%. Our fixed income positions were flat.

Our largest winner on the month was Zebra Technologies (ZBRA), a long position, which added 0.31%. ZBRA is a name we have discussed numerous times. The company and management team continue to focus on providing products and solutions which make global supply chains more efficient.

Blue Owl Capital, (OWL), a long, was the fund's largest loser on the month costing the fund -0.34%. OWL traded lower during the month along with other financials. Blue Owl is an alternative asset management firm which offers investors access to private lending, real estate, and private equity opportunities. We believe OWL is very well positioned to continue to capture market share. With yields globally trading near historic lows, investors are focused on alternative income producing assets that have little to no correlation to the equity markets. The company has numerous strategies which will attract the interest of both institutional and retail investors in such an environment. We believe that OWL could be a significant winner in the years ahead as more investors discover the opportunities and earnings potential of the company.

The Standard and Poor's 500 Index (S&P 500) is a capitalization-weighted index of 500 stocks. The index is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries. The S&P 500 Equal Weight index is the equal-weight version of the S&P 500 index. It includes the same securities as the S&P 500 but each company is allocated a fixed weight of the index at each quarterly rebalance. The Bloomberg Barclays US Aggregate Bond Index is a broad-based benchmark that measures the investment grade, US dollar-denominated, fixed-rate taxable bond market. The 60/40 S&P 500 Equal Weight and Barclays Aggregate Bond Index as described herein, takes 60% of the S&P 500 Equal Weight index return and 40% of the Bloomberg Barclays US Aggregate Bond Index in order to better represent the investment strategy of the Fund. It is not possible to invest directly in an index. Delta is the ratio comparing the change in price of the underlying asset to the corresponding change in the price of a derivative. Standard deviation is a measure of the dispersion of a set of data from its mean. Correlation is a statistical measure of how two securities move in relation to each other. The correlation coefficient (r) is a measure that determines the degree to which two variable's movements are associated. The coefficient of determination (r2) is a measure used in statistical model analysis to assess how well a model explains and predicts future outcomes.
