- Value factors include book value-to-price ratio, sales-to-price ratio, and earnings-toprice ratio



BENCHMARK S&P Pure Style Indices Rydex S&P Pure Style mutual funds are benchmarked to the S&P Pure Style Indices. The indices use a quantitative rules-based selection process to include only those stocks exhibiting strong growth or value characteristics. Stocks are selected if they show growth or value characteristics that meet minimum style score criteria while stocks with overlapping growth and value characteristics are eliminated. Stocks are weighted according to their style scores, as opposed to being weighted by market capitalization.
