- Overweighting a market segment without additional cash


#### Fund performance and benchmark history<sup>2</sup>

ProShares Ultra Silver seeks a return that is 2x the return of a benchmark (target) for a single day, as measured from one NAV calculation to the next. Due to the compounding of daily returns, holding periods of greater than one day can result in returns that are significantly different than the target return and ProShares' returns over periods other than one day will likely differ in amount and possibly direction from the target return for the same period. These effects may be more pronounced in funds with larger or inverse multiples and in funds with volatile benchmarks. Investors should monitor their holdings as frequently as daily. Investors should consult the prospectus for further details on the calculation of the returns and the risks associated with investing in this product.

## Benchmark description

The Bloomberg Silver Subindex<sup>SM</sup>, a subindex of the Bloomberg Commodity Index, is intended to reflect the performance of silver as measured by the price of COMEX silver futures contracts. It is a "rolling index," which means that it does not take physical possession of any commodities. The roll occurs over a period of five business days in certain months according to a pre-determined schedule, generally beginning on the sixth business day of the month and ending on the tenth business day. Each day, approximately 20% of each rolling futures position that is included in the month's roll is rolled, increasing from 0% to 20%, 40%, 60%, 80% and finally 100%. The Silver Subindex will reflect the performance of its underlying COMEX silver futures contracts, including the impact of rolling, without regard to income earned on cash positions.
