


#### Who We Are

## **Philosophy**

Alger has been committed to a growth style of investing since the firm was founded in 1964. We believe that the best way to uncover and evaluate such companies is through intensive, fundamental, proprietary investment research. At Alger, we believe companies undergoing **Positive Dynamic Change** offer the best investment opportunities. By Positive Dynamic Change, we mean those companies experiencing High Unit Volume Growth and Positive Life Cycle Change.



#### **Process**

NEW IDEAS

Alger's experienced emerging markets team gathers high unit volume growth and positive life cycle change ideas from their research and deep relationships within local markets. Additionally, they regularly review screens of the entire universe, which may uncover new ideas.

ANALYSIS

The team performs in-depth company analysis and detailed financial modeling to develop a differentiated view. In addition to their bottom-up stock-specific analysis, the team also analyzes an individual country's economic, fiscal, political, and market trends.

DIALOGUE

The team's communication is constant, collaborative, and leverages each team member's expertise in specific country/regions and sectors. The team formally meets weekly to review the portfolio, discuss in-progress research, and set future research priorities.

CONSTRUCTION

Alger Emerging Markets is a best ideas portfolio made up of our highest conviction names across the emerging markets universe. Positions are typically initiated with the goal that they become 1% of the portfolio and generally no larger than 5%. The portfolio seeks to have at least 80% active share, with risk managed through broadly diversified holdings—across countries, market caps, and sectors.

MONITORING

The team continuously reviews performance to stress-test the underlying investment thesis at a security and country level. If the thesis remains intact or is revised upward, there may be a buying opportunity; otherwise the position will be sold as new ideas are developed.

Fred Alger Management, LLC has contractually agreed to waive fees or to reimburse Fund expenses (excluding acquired fund fees and expenses, dividend expense on short sales, borrowing costs, interest, taxes, brokerage and extraordinary expenses) through February 28, 2023 to the extent necessary to limit the annual operating expenses of Class A to 1.55%, Class I to 1.45% and Class Z to 0.99% of the class's average daily net assets. This expense reimbursement may only be amended or terminated prior to its expiration date by agreement between Fred Alger Management, LLC and the Fund's Board of Trustees, and will terminate automatically in the event of termination of the Investment Advisory Agreement. Fred Alger Management, LLC may, during the term of the contract, recoup any fees waived or expenses reimbursed pursuant to the contract to the extent that such recoupment would not cause the expense ratio to exceed the stated limitation in effect at the time of (i) the waiver or reimbursement and (ii) the recoupment by Fred Alger Management, LLC, after repayment of the recoupment is taken into account.




