

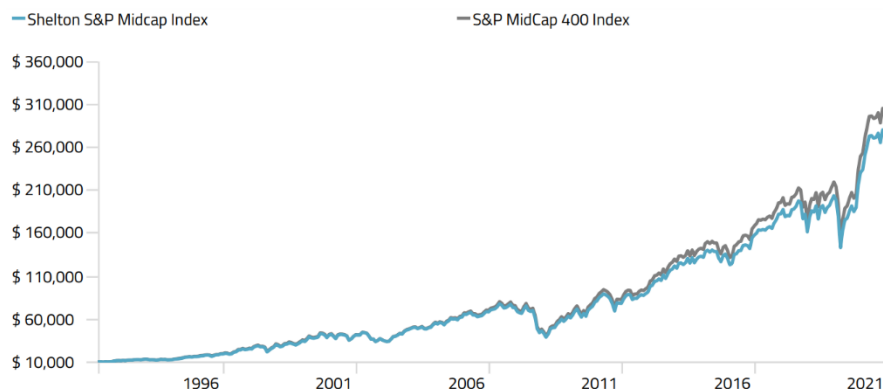
Fund Objective
