

# Gateway Equity Call Premium Fund

#### Fund Highlights<sup>1,2</sup>

- A low-volatility equity fund that combines an index-like portfolio of underlying equity securities with a
  portfolio of actively managed written index call options
- Consistent and attractive cash flow from index call writing creates potential for better long-term riskadjusted returns than the equity market
- May be used as a component of an equity allocation or an alternatives program seeking equity market participation with reduced sensitivity to market swings; the fund is managed to maintain low correlation with fixed-income market returns and no significant sensitivity to changes in interest rates

Fund uses the same investment strategy under all market conditions



Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. The top 10% of funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star (each share class is counted as a fraction of one fund within this scale and rated separately, which may cause slight variations in the distribution percentages). 
