



Intoppa are the fund's primary portfolio managers, positions they have held since October 2019 and November 2020, respectively. Mr. Chu is a vice president and senior research analyst on the Global Equity Research team at Newton Investment Management North America LLC (Newton), an affiliate of BNYM Investment Adviser. Mr. Intoppa is a director and senior research analyst on the Dynamic Large Cap Value Strategy at Newton.
