Fund Information

Began operations: June 17, 1999

Objective: The fund's investment objective is long-term capital appreciation.

Distinguishing characteristics: This strategy seeks broad exposure to emerging markets opportunities, principally by investing in emerging markets companies as well as multinational companies with material emerging markets exposure. It also includes a relatively small opportunistic sleeve of emerging markets fixed income with attractive total return potential. Over the long term, the strategy has provided emerging markets-like returns with developed markets-like volatility.*

Portfolio restrictions: The fund may invest in debt securities, which may be rated below investment grade (BB/BA and below, or unrated, but determined by the fund's investment adviser to be of equivalent quality).


