Began operations: March 26, 1993

Objective: The fund's investment objective is to provide long-term growth of capital while providing current income.

Distinguishing characteristics: This strategy has the flexibility to seek growth and income opportunities around the world. It invests primarily in seasoned companies, including those paying regular dividends and those with attractive growth prospects. Historically, this diverse strategy has provided lower volatility and better downside protection than its peers.*

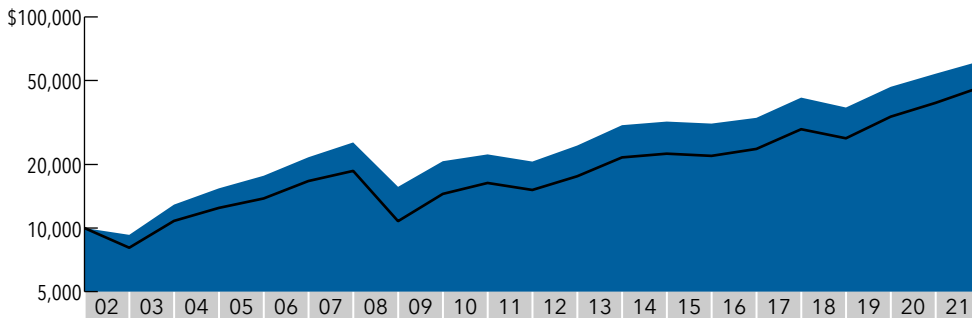
