

Calvert US Mid-Cap Core Responsible Index Fund

Fund Overview

The Fund seeks to track the performance of the Calvert US Mid-Cap Core Responsible Index which is composed of common stocks of mid-size companies selected from the 1,000 largest publicly-traded U.S. companies based on market capitalization, excluding approximately the 200 largest publicly-traded U.S. companies. It offers broad exposure to companies that meet The Calvert Principles for Responsible Investment (Calvert Principles).

Research Process

Calvert Research and Management conducts deep, proprietary research across approximately 200 peer groups using over 200 key performance indicators (KPIs) to measure material environmental, social, and governance (ESG) factors. The Calvert US Mid-Cap Core Responsible Index has approximately 600 holdings that are reconstituted annually and are rebalanced quarterly.

The Calvert Principles provide a framework for considering ESG factors and guide Calvert's active engagement efforts with company management.

- **AmerisourceBergen Corp:** Continued litigation related to opioid revenue

[†]Class I Ratings: 3-year: 5 stars; 5-year: 5 stars. The total number of funds in the Mid-Cap Blend category for the 3-, and 5-year periods are 357 and 290, respectively. The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds and exchange-traded funds) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics.
