### **Fund description**

The Fund seeks a favorable long-term total return, mainly through capital appreciation. It normally invests at least 80% of its assets in small-cap and mid-cap equity securities. The Fund seeks to invest in companies across a wide range of sectors, growth rates and valuations. The Fund's management team seeks to add incremental returns over its stated benchmark index, while also managing the relative risk of the Fund versus its benchmark index. The Fund's management team uses proprietary quantitative models based on financial and investment theories to evaluate and score a broad universe of stocks in which the Fund invests. The Fund will invest primarily in securities within the capitalization range of companies included in the Russell 2500<sup>™</sup> Index.

#### Glossary

Beta is a measure of the volatility of a portfolio relative to the overall market. A beta less than 1.0 indicates lower risk than the market; a beta greater than 1.0 indicates higher risk than the market. P/E ratio of a stock is calculated by dividing the current price of the stock by its forecasted 12 months' earnings per share. The average

of the price/earnings ratio of a fund is a weighted harmonic average of all the current P/E ratios (excluding negatives) of the stocks in the Fund's portfolio. This should not be construed as a forecast of the Fund's performance. **Standard deviation** is a statistical measure of the historical volatility of a mutual fund or portfolio; the higher the number the greater the risk. **Turnover ratio** is calculated by dividing the lesser of purchases or sales by the average value of portfolio assets during a period.
